KNOW ALL BY THESE PRESENTS, that the undersigned hereby constitutes and appoints Charles E. Baker, Donald C. Lewis, Robert W. McClelland, Mary L. Rose and David A. Westerlund, and each of them acting or signing alone, as his or her true and lawful attorney-in-fact to:
